#### 2. Context

#### **Overview of the project**

**Gram-Utthan** is a non-profit community-based organization established in 1990 and formally registered in 1990 organization's Registration Act XXI of 1860. For a significant increase in aquaculture production, productivity and profitability, Gram-Utthan organizes the unorganized aquaculture farmers into the FPO folders by strengthening them to improve Natural Aquaculture Practices. The organisation uses two main principles: 1.Information: providing up-to-date information on agro-forestry farmers

2. Improvement: Engagement of farmers by improving their income pattern, Soil Conservation, Reduce Carbon in the earth.

Certified Nursery for procurement of various fruit bearing and forestry saplings to provide selected farmers those are interest for the TARU project and they have Chaka Land minimum 1 Acre. Total area of plantation is 500 Hectare in Gondia, Dhenkanal Sadar, Kamakhyanagar block of Dhenkanal district and Begunia, Tangi block of Khordha district.

#### 3.1.1. Work Package I. Sapling Distribution to Farmer:

- The bidder will supply the Saplings to the selected farmer who will meet the necessary criterial of TARU project, the details list of farmer is share at the time of Issuring of Purchase Order.
- The bidder will provide certified best quality shipping of its own or procure from certified sources.
- The bidder should distribute only Mango, Guava, Bettlenut, Jamun, Jackfruit, Plam, Litchi, Sepata,
- The Sapling size should be 2feet to 3feet inches, the body & head structures will be ideal size, No mark of injuries in paint & the plant should be disease free.
- The Saplings should be distributed in appropriate vehicle, No overloaded, where no damage during transit.
- Total 500 Hac of plantation in Dhenkanal and Khordha district.
- The saplings are handed over to the farmer in different location at the farmland site, the details of the blocks and location is reflected in Purchase Order. The District And Block name is mention below

## 4. Concept:

In the bid, the bidder is required to show the proof of certified & good quality of saplings if he will procure from another sources. The Saplings should be good quality & the samples should have passed through

1. **Root system**: A well-developed root system with a strong taproot and plenty of fibrous roots.

2. **Stem**: A straight, sturdy stem with a smooth, even texture.

3. Leaves: Healthy, vibrant leaves with no signs of pests or diseases.

4. **Graft union**: A strong, well-healed graft union (if applicable).

5. **Height and diameter**: Saplings with a balanced height and diameter, suitable for the specific variety.

6. **Vigor**: Saplings with good vigor, indicating healthy growth and development.

7. Pest and disease-free: Saplings should be free from pests and diseases.

8. True-to-type: Saplings should exhibit characteristics true to the variety.

9. **Age**: Saplings should be of suitable age for planting in the main field (as discussed earlier).

10. **Certification**: Consider certified saplings from reputable nurseries or suppliers.

## 5. Criteria for Eligibility of firms:

Note: Bidders have to submit the document of evidence for the criteria specified below:

- 1. The primary bidder should have a minimum 5 years of experience in Nursery raising & providing best quality of saplings in the market.
- 2. Successfully distributed around 5 lakhs of Saplings per year throughout Odisha.
- 3. The Bidder should have its own distribution/Delivery channel.
- 4. The bidding organizations require an average annual turnover of 10 Lakh INR or equivalent over the last three financial years and must have employed, as on 31 March-2024.
- 5. The bidder should have own/Hire vehicle for distribution.
- 6. The bidder should have professional team to load and unload the saplings.
